Dear Members,

'IOD Foundation' supports the corporates in implementation of their projects, in the cause of upliftment of the needy segments of the society. The 'IOD Foundation' provides a strong professional support for implementation of corporate CSR projects.

'IOD Foundation' acts as a support system for taking care of serving and addressing certain pressing issues of the economy, like 'Protection of Children's Rights', 'Women Empowerment', help Senior Citizens, enable persons with disabilities, promote Education, Health, Natural Resource Management, support development of agriculture, promote art and craft, preserve the cultural heritage, etc. These are just an indication of the vast variety of areas, in which it can work to bring about a difference in the society.

It is more than imperative that the 'IOD Foundation' abides by these 'principles of good governance', in true letter and spirit. It is a guide for undertaking activities of charitable and philanthropic nature, which seek to promote the goals of inclusive growth and development in the economies globally. IOD Foundation may take necessary steps to provide for an online platform, to encourage and promote e-filing of forms and disclosures for greater transparency. IOD Foundation's 'Code of Conduct 2021' is a Model Code of Governance, which provides a set of guiding principles and standards for 'IOD Foundation', established as a charitable organization.





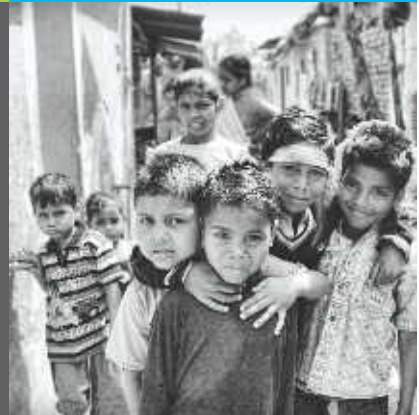

ACTIVITIES OF IOD FOUNDATION

Charity and philanthropy have formed the core of every society across the globe. The Indian scenario is no different. It is more than imperative that each 'IOD Foundation' abides by principles of good governance in true letter and spirit. It is a vehicle for undertaking activities of charitable and philanthropic nature, which seek to promote the goals of inclusive growth and development in the economies globally.

IOD Foundation acts as a support system by taking care of, serving and addressing certain pressing issues in the economy. Protection of Children Rights, Women Empowerment, Senior Citizens, Enabling Persons with Disabilities, Promoting Education, Health, Natural Resource Management, Supporting Development of Agriculture, Promoting Art and Craft, Preserving the Cultural Heritage, etc., are just an indication of the vast variety of areas in which it can work to bring about a difference in the society.

Since 'IOD Foundation' relies on money from various sources, including individual donors, foundations, corporations, and governments, its utmost responsibility is to ensure highest

IOD Foundation has started its activities from the day of its formal registration. Foundation has organized multiple social activities in association with number of social foundations like Nagrik Foundation, ActionAid Association and The Akshaya Patra Foundation.

Campaign for Covid Testing: IOD Foundation organized a special Covid testing campaign in New Delhi. With the rising cases of the Covid-19 virus in check, a campaign (#wecareforyou) was launched with the aim of ensuring continued good health and safety of the workforce and their families. Under this campaign, complimentary Covid-19 tests were carried out to ensure safety for all and the society at large.



Distribution of Blankets & Non-Perishable Food Items: IOD Foundation organized a Program under “Warmth for the underprivileged” at the Sangam Vihar Colony, New Delhi and distributed Blankets & Non Perishable Food items to the underprivileged people of underprivileged families of the colony. The Program was organized under the Covid-19 protocol. Face masks & Hand sanitizer were also provided to all participants. More than 30 underprivileged families participated in this program. They were from nearby slum areas of Sangam Vihar.

Education Support Program: IOD Foundation launched an “Education Support Programme” at the school for Remedial Class managed and run by Prachodana Social Service Society, IGNOU Road, New Delhi. Reeducation to school drop-outs and underprivileged children as a priority area. Gaps have been identified in on-going schools for the underprivileged children in terms of quality books, stationery and also nutritious food supplement. Approach in terms of providing appropriate support material has been identified in consultation with experts, and a 'support package' has been developed by the Foundation. IOD Foundation distributed stationery /text books/ and story books & food packets to launch this project. A total number of 60 underprivileged students, mostly children from the nearby slum areas are studying at this school. The Prachodana Social Service Society is engaged with IOD Foundation to get support through various education support activities, which can lead to a positive impact on their growth. These activities are empowering the underprivileged to promote inclusive social and national growth.



Education Support Program with Institution for the Blind School: IOD Foundation has organized an Educational Support Program with the Institution For the Blind School, Amar Colony, New Delhi with the Slogan “Bringing Light to the Blind”. IOD Foundation distributed P2 School bags, Pen drive & Other Stationary items to the blind students as per their requirements. IOD Foundation also distributed Non Perishable Food items to these students. Program was organized under the Covid-19 protocol. Face masks & Hand sanitizer were also provided to all participants. More than 40 underprivileged Blind students of their institute participated in the programme. The Institution for the Blind School is engaged with IOD Foundation to get support through various education support activities, which can lead to a positive impact on their growth. These activities are empowering the underprivileged blind students to promote inclusive social and national growth.

Distribution of Non-Perishable Food Items for Old Age Home: IOD Foundation organized a special function at Prachodana Social Service Society, 439/33, Pocket 12, Jasola Village, New Delhi-25, for distributing Non Perishable Food items to all, in Old Age Home. A total of 25 aged homeless people are being cared by the Prachodana Social Service Society, since long. Most of the people were picked up from the road side by the society. The

Prachodana Social Service Society is engaged with IOD Foundation to get support through various activities, leading to a positive impact on the aged homeless people. IOD Foundation recognized nutritious food as one of the basic requirement which had a gap, and therefore provided that support. The Foundation has launched this initiative and has committed to support through such nutritious interventions. IOD Foundation present at the function distributed Nutritious Food Packets, which contained non perishable food items, including Oat Meal, Milk Powder, Raisins, Glucose and other Nutritious items. 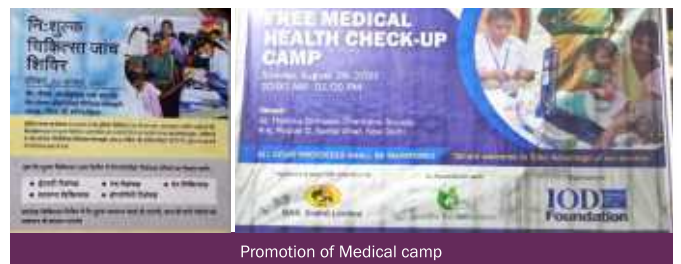

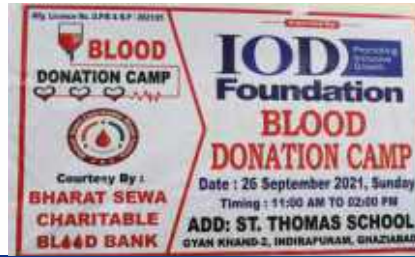
